### **Frequently Asked Questions**

### What is CAIVRS?

The Credit Alert System (CAIVRS) is a shared database of defaulted federal debtors. It was developed by the Department of Housing and Urban Development (HUD) in 1987 as a multiagency resource.

### How is CAIVRS used?

CAIVRS is used to prescreen and verify the eligibility of applicants of federal direct or guaranteed loans. Agencies use CAIVRS to determine if a loan applicant has:

- Defaulted on any federal debts or obligations
- Had claims paid on direct or guaranteed federal loans
- Had a federal lien, judgment or federal loan that is currently in default or foreclosure
- Had a claim paid by a reporting agency within the last three years

# Which federal agencies currently send delinquency data to DNP?

- Department of Housing and Urban Development (HUD)
- Department of Veterans Affairs (VA)
- Department of Agriculture (USDA)
- Small Business Administration (SBA)
- Department of Justice (DOJ)

### How do I gain access to CAIVRS through DNP?

To initiate the DNP enrollment process, send an email to donotpay@stls.frb.org or call 1-855-837-4391.

#### Do I need to use CAIVRS?

Yes, the Improper Payments Elimination and Recovery Improvement Act of 2012 identified CAIVRS as one of the databases to be used in the Do Not Pay Initiative to determine applicant eligibility prior to disbursing federal funds or federally guaranteed funds.

## What DNP Portal functions match against CAIVRS?

CAIVRS is currently only available through the Online Search function in the DNP Portal.

### What information does CAIVRS contain?

The following chart lists the data elements that are sent from each reporting agency. (See page two for descriptions of these fields.)

## How frequently is CAIVRS updated within the Portal?

DNP refreshes the entire CAIVRS database each time any agency source forwards an update. The agency sources provide updated data at various points throughout the month.

# How has DNP made using CAIVRS easier for agency users?

The two-digit code identifying the reporting agency has been replaced by the name of the agency; the type of case is now spelled out, instead of abbreviated with the first letter; and new reporting agencies continue to be added.

### **CAIVRS Data Elements Returned in the Portal**

The data elements presented in the Portal when a match occurs are described below.

Column Heading	Description			
TIN	The Social Security Number (SSN), Employer Identification Number (EIN) or Taxpayer Identification Number (TIN) of the borrower on a delinquent or defaulted federal direct loan or federally guaranteed loan			
Tax ID Type	An indicator of the type of Borrower ID Number: SSN, EIN, TIN			
Agency	The CAIVRS reporting agency: HUD, VA, USDA, SBA, DOJ			
Case Type	An indicator of the type of delinquency referenced: CLAIM, DEFAULT, FORECLOSURE, LIEN, JUDGMENT			
Case Number	A reference number issued by the reporting agency for the delinquent or defaulted federal direct loan or federally guaranteed loan			
Collection Code	A reference number indicating the collection district (only provided in DOJ data)			
Collection Description	A description of the collection district (only provided in DOJ data)			
Phone Number	The phone number of the collection district (only provided in DOJ data)
