INTENT TO SOLE SOURCE SLCGOODS, LLC SS-AFRH-25-058

The Bureau of the Fiscal Service (Fiscal Service), on behalf of Armed Forces Retirement Home – Washington, D.C. Campus intends to contract with SLC GOODS, LLC, 8603 Flagman Trail, Fulshear, TX 77441-1944, on a sole source basis to resurface AFRH's rehabilitation pool under PSC Z1PA at their Washington, D.C. Campus.

The existing maintenance and service contract for the facility's swimming pool was awarded on 05/01/2025 and has a period of performance of up to five years. It includes routine inspections, chemical balancing, minor repairs, and equipment servicing to ensure the pool remains safe, operational, and compliant with all health and safety standards. During the course of these services, the contractor has identified significant degradation of the pool's surface, including visible cracking, chipping, and erosion of the finish, which present safety hazards, jeopardizes the long-term integrity of the structure and hinders the contractor's ability to effectively perform the maintenance and services needed to fulfill the existing contractual obligations.

The current contractor possesses in-depth knowledge of the facility's pool system, including its construction, usage patterns, and maintenance history. This expertise makes them uniquely qualified to execute the resurfacing with minimal disruption and maximum efficiency. Engaging a new contractor would result in redundant mobilization, additional inspection and evaluation costs, and a steeper learning curve, potentially leading to increased downtime and higher overall project costs.

Furthermore, awarding the resurfacing as a logical follow-on to the existing contractor protects the integrity of any active warranties associated with prior maintenance and system components. May pool equipment and surface warranties are contingent upon work being performed by authorized or previously engaged service providers. Bringing in a third-party vendor could jeopardize those warranties, potentially resulting in future out-of-pocked costs for repairs that would otherwise be covered.

Awarding this logical follow-on contract to the incumbent provider ensures continuity of service, preserves existing warranties, and maintains the integrity and safety of the pool in a cost-effective and timely manner. This approach aligns with sound procurement practices by reducing risk, avoiding duplication of effort, and ensuring accountability through a single point of service.
