There was a 5% increase in the EFT volume for SSA payments and a 3% decrease in the check volume in December 2009 as compared to December 2008. SSA issued 196,629 fewer check payments in December 2009 as compared to December 2008. The volume for SSA was increased for EFT by 106,056 and the SSI EFT volume was decreased by 106,056. The volume for SSA check payments was increased by 37,022 and the SSI check volume was decreased by 37,022. This was due to an inadvertent switch between the two payment types.
