What's Coming with Release 4.1

- Seller Facilitated Orders (SFO)
- Agencies will be able to assign Subordinate Groups & select DII in the GT&C
- Enhanced Org Tree option for Group Name & Description in GT&C details
 - Expand/Collapse All Buttons Added
 - Option to Select from Org Tree not available with R4.1 (future enhancement)
- Improved Accessibility
- Scheduled Production Deployment for Spring 2021
- Overview Webinars will be scheduled in March



What's Next

- Development underway for Release 4.2 to align the application with the interface specifications published in June 2020.
 - Specifications frozen to allow vendors to build & test
 - Order Closure Rules
 - Performance Rules
 - Deferred Payments
 - Adjustments (Refunds)
 - Date Rules
 - Quantity Rules

January Survey Results

- Consensus from agencies the information presented in the Trading Partner Directory was helpful
- Suggested improvements to the Trading Partner Directory included:
 - Listing the AIT assigned to each agency
 - Notating agencies with phased implementations (ex. GSA)
 - Include Org structures and where the organizations are in the implementation process
 - Listing all agencies, even if an agency hasn't established a production account
- Majority of those who responded felt no additional items should be collected on the Attachment A and B
- Suggested future Office Hours topics included:
 - Phased Implementations (how other agencies are handling it)
 - Performance transactions in G-Invoicing (including advances & refunds)
 - Creating GT&C's when your trading partner is not in production
 - Additional 7600A/B discussions
 - Lessons learned from agencies
